## **Conference Description:**

Riverside Trauma Center's 10th Annual Conference entitled "Cultivating a Trauma-Informed Workplace: Caring for Human Service Workers" will be held virtually on October 23rd, 2020. This year's focus will be on trauma-informed and culturally responsive approaches to serving the human service workforce from the perspective of the organization. Our speakers and panelists will discuss how taking care of our most valuable resource – the people doing the work – by creating more compassionate, supportive, and trauma-informed organizations, fosters a deeper ability to thrive in daily work.

## **Keynote Presentations:**

### **"The Children's Fire for Trauma Informed Organizations"**

**Lea S. Denny, MS, LPC, NCC, NMT, CEO, Founder, HIR Wellness Institute**

This Keynote will focus on the Healing Intergenerational Roots (HIR) Wellness Institute and how it was developed around a Trauma-Informed and the Intergenerational Healing Approach™ (IHA). This was done with the respect to and ancestral knowledge of The Children's Fire. This will be achieved by 1) Exploring the principles of the Children's Fire and shared leadership practices for organizational care, 2) Review concepts of Historical Trauma as Transgenerational Trauma Transmission, 3) Defining Persistent Toxic Systems and Environments™ (PTSE), Triple Attunement™, Community Activate Medicine™ (CAM) and finally, 4) Demonstrate the social justice-informed and Intergenerational Healing Approach™.

### **"Creating Safe and Supportive Environments: Moving Beyond Asking "What happened to you?""**

**Joanna Bridger, LICSW, Clinical Director, Riverside Trauma Center**

Joanna Bridger will discuss Riverside Trauma Center's Safe, Supportive and Trauma-Informed Environments initiative. She will present on the suite of services and comprehensive trauma-informed work done by Riverside Trauma Center's embedded clinicians who work extensively with human service organizations to support workers in high stress/trauma exposure programs.

## **Panel Discussion:**

Panelists represent human service workers from education, public health, mental health and the LGBTQIA+ community. They will talk about the ways that their organizations approach trauma-informed care for those served and those doing the work. Panelists represent a broad range of experience with developing trauma-informed organizations.
